## STAKEHOLDER NOTIFICATION

The President of the Republic of South Africa (RSA), Honourable Cyril Ramaphosa, declared the coronavirus (COVID-19) outbreak a national disaster on 15 March 2020. The Transport Education Training Authority (TETA) is taking precautionary measures in an effort to play a role in minimising the spread of COVID-19 virus. This has resulted in the implementation of several changes that will affect how stakeholders have been interacting with TETA.

### - REMOTE OPERATIONS

### - TRAVEL RESTRICTIONS
